## What's in this document?

This document is a *Draft Environmental Impact Statement/Report* (DEIS/R) and *Draft Section 4(f) Evaluation*, which examines the potential environmental impacts of alternatives for the proposed project located in San Francisco, California. The document describes why the project is being proposed, alternatives for constructing the project, the existing environment that could be affected by the project, and potential impacts from each of the alternatives.

## What should you do?

- ▶ We welcome your comments. If you have any concerns regarding the proposed project, please attend the Public Information Meeting and/or send your written comments to the San Francisco County Transportation Authority (Authority) by the deadline. ## What happens after this?

After comments are received from the public and reviewing agencies, Federal Highway Administration and the Authority may (1) identify a preferred alternative and give environmental approval to the proposed project, (2) undertake additional environmental studies, or (3) abandon the project. If the project were given environmental approval and funding were appropriated, the final design and construction of all or part of the project would proceed.
